Pohakuloa Training Area (PTA)	This project will help to remediate existing inadequate facilities at Branshaw Army Airfield that are encroaching into the 500-ft. clear zone for the Class A Runway.	Hawaii County HI	\$20,000
Joint Base Pearl Harbor-Hickam	Provides a drinking water treatment facility for removing potential contaminants at the Red Hill water supply shaft and ensure that treated water continues to meet all Federal and State drinking water standards.	Honolulu County HI	\$505,000
Army Garrison Hawaii	Construction of a Wildland Fire Station that would have dormitories, an admin building, training space, a firetruck building, and an all-terrain storage building. This facility would be able to house six firefighters and one chief.	Honolulu County HI	\$21,000
Hickam Air Force Base	These design funds would support a facility for multi-domain operations with the proper enhancements to facilitate collaboration in a space secure for classified work.	Honolulu County HI	\$5,000
Wheeler Army Airfield	This project will construct an Aircraft Rinse Facility, per Army Standard, at Wheeler AAF. The project is crucial for performing corrosion control in support of three active-duty aviation battalions operating rotary wing aircraft in the highly corrosive Pacific Theater environment. Army Garrison Hawaii	Construct a new facility to accommodate living spaces for 432 soldiers.	Honolulu County HI	\$18,000
Hickam Air Force Base	This project provides design funding to construct a C-17 Maintenance Hangar facility. If this facility is not provided, the current configuration of hangar maintenance will continue to be overutilized and impact the Wing's ability to meet current and future missions. Hickam Air Force Base	This project will repair and renovate one bay of Hangar 35 to support the maintenance hangar requirement for servicing C-17 and KC-135 aircrafts at Joint Base Pearl Harbor Hickam. Without the project, the current distressed facility will continue to impact the Wing's mission readiness.	Honolulu County HI	\$6,000
