Dear Member of Congress,

Today LGBTQI+ youth in schools across the country are under attack by lawmakers who seek to exclude and erase communities through transgender athletic bans, curriculum censorship laws, and other discriminatory legislation. The undersigned 148 LGBTQI+, Civil Rights, and K-12 Education organizations urge you to co-sponsor the Rise Up for LGBTQI+ Youth in Schools resolution that calls for an end to bias-based discrimination, bullying and harassment, curriculum censorship, and all forms of victimization and erasure of communities in schools.

As educators and advocates from across the country who represent multi-racial, intergenerational LGBTQI+ inclusive organizations, we hear directly from students, their teachers, and families about the impacts of transphobia, homophobia, racism, sexism, and ableism that create toxic and harmful school environments. Findings from GLSEN's 2021 National School Climate Survey indicate that victimization of LGBTQI+ youth in schools remains prevalent and that LGBTQI+ inclusive best practices lead to improved wellness and achievement:

- Schools nationwide are hostile environments for a distressing number of LGBTQI+ students, the overwhelming majority of whom routinely hear anti-LGBTQI+ language and experience victimization and discrimination at school. As a result, many LGBTQI+ students avoid school activities or miss school entirely.
- A hostile school climate affects students' academic success and mental health. LGBTQI+ students who experience victimization and discrimination at school have worse educational outcomes and poorer psychological well-being.
- Transgender students, in general, experienced the most hostile school climates compared to their peers.
- Native and Indigenous LGBTQI+, or Two Spirit, students experienced more hostile school climates than their peers of other racial/ ethnic groups.
- Black students were more likely than most other students to feel unsafe due to their race/ethnicity.
- Over half of all LGBTQI+ students of color experienced in-person victimization based on race/ethnicity.
- Students who feel safe and supported at school have better educational outcomes. LGBTQI+ students who have LGBTQI+ affirming school resources report better school experiences and academic success. Unfortunately, all too many schools fail to provide these critical resources.

The Rise Up resolution calls for an end to the victimization and erasure of LGBTQI+ people in education. Schools must at minimum be safe and ultimately places of liberation where every young person can thrive and reach their full potential. By adopting comprehensive policies that prohibit victimization, supporting GSAs (Gender and Sexuality Alliances or Gay Straight Alliances) and

other youth leadership initiatives, empowering educators and other adult allies to affirm all students, and teaching inclusive curriculum that promotes visibility and representation of all communities that experience marginalization, we can positively transform schools so that all students can learn and teachers can teach.
